**MATTER MOST SENSITIVE ACTIONABLE BY EDUCATIONAL
INSTITUTION AND TRANSPORT DEPARTMENTS, WP NO.2683-P/2011
MUHAMMAD ISA KHAN VS GOVT. OF KHYBER PAKHTUNKHWA.**

I am directed to refer on subject cited above and to inform your goodself that as decided in a meeting held on November 02, 2015 under the chairmanship of Deputy Commissioner Peshawar, that the Suzuki (Pick-up) is an unauthorized/unsafe way of transportation of children to schools as used in urban area as per RTA (Regional Transport Authority). The use of same vehicles is against the law, generally used by the school/colleges and university at large. Furthermore, all these vehicles are CNG (Compressed Natural Gas) fitted with single or double cylinder, and protective fences as iron steps generally used by students to stand on. The school bags are hanged on both sides of these Suzuki (Pick-Up), which is a traffic hazard for other vehicles.

The honourable Supreme Court of Pakistan has ordered to stop all vehicles having CNG specially Suzuki (Pick Up) in urban are to be used for school/colleges transportation to play on Category-A roads.

In this regard you are informed to direct all the students/parents to ban the use of Suzuki as school/college carriage vehicle and having CNG fitted cylinders is against the order of Supreme Court of Pakistan Islamabad. Furthermore, to avoid any untoward incident (like explosion of CNG cylinder or burning of all inside students) and implementation of Court order, ban the use of Suzuki within 15 days. In case of non-compliance, under Ordinance 2002, strict action shall be initiated including imposition of penalty and de-affiliation with BISE Peshawar.
