- **1.** The meeting regarding subject agenda was held on March 22, 2021 at Committee Room of Board of Intermediate and Secondary Education, Peshawar.
- 2. Mr. Hayat Muhammad, Procurement Officer welcomed the participants and briefed them about the project.

- **3.** The Project Manager, M/s Barg Engineering discussed the following points:
 - The letter of invitation followed by the instructions to the bidders regarding mandatory criteria for bidding the project. All the points were discussed one by one in detail.
 - Refer to IB 2.1, point 15, correction was made and is as mentioned below;

 "The bidder should have an average annual turnover in the **last three years** equal to or more than the Total Bid Price. (Auditors report for last 03 years shall be provided)"
 - Specific works data and Technical compliance sheet for prospective bidders.
 - Schedule of prices summary of bid prices.
 - Sub-Clause 33.1; Terms of Payment.
 - Basic Block diagram for the project (drawing is conceptual and shall be used for reference purposes, not exactly to be followed by the contractors rather they shall prepare their own and submit it in the technical proposal).
 - Project Manager announced that handing/taking over certificate shall be signed when the contractor installed the net meter along with completing all other documental formalities required for installation of net meter.
- 4. Project Consultant announced that the bidder should have successfully completed any Solar Building project (ON-GRID/ON-GRID Hybrid having installed PV capacity ≥ than 100kW with proof of Net metering License from NEPRA) and satisfactory completion certificate from the concerned department shall be attached as a proof.
- **5.** The NIT (Notice Inviting Tender) was published late in the Daily Mashriq newspaper on March 20, 2021 due to delay by information department, KP whereas BISE Peshawar delivered the NIT to information department, KP on March 11, 2021 for publication in daily newspapers. According to KPPRA rule 43(1), the response time shall not be less than 15 days from the date of publication of advertisement, therefore, the committee decided to issue a corrigendum in daily newspaper regarding submission of technical & Financial Proposals date and that will be April 06, 2021 with same time for submission and opening of technical bids.
