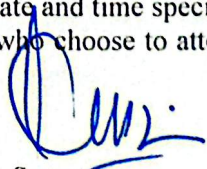
Through EPADS (E-Pak Acquisition & Disposal System)

BISE Peshawar, invites bids through the E-PADS system for the following items from manufacturers, importers, authorized dealers, companies, firms (including individual business firms) and general order suppliers who are duly registered with the relevant tax authorities, including KPRA (where applicable) and FBR for Income Tax and Sales Tax, and who are listed on the Active Taxpayers List (ATL).

Terms & Conditions:

1. **Bid Solicitation Documents (BSDs)** shall be available for download from the E-PADS portal (<https://kp.eprocure.gov.pk/>) under the "Active Tenders" section, until the closing date and time of bid submission. The advertisement shall also be available on the official website of BISE Peshawar (www.bisep.edu.pk) and the KPPRA website (www.kppra.gov.pk).
2. **Only those bidders** who are duly registered on the E-PADS system shall be eligible to participate in the bidding process.
3. **All bids, along with the required supporting documents**, shall be submitted electronically through the E-PADS system in accordance with the instructions contained in the BSDs.
4. No hard copies of bids shall be accepted. However, **the original bid security**, in the form of CDR / Bank Guarantee (unconditional and irrevocable) issued by a Scheduled Bank, shall be submitted separately in a sealed envelope clearly mentioning the **Tender Number and title**. The bid security envelope must reach the office of the undersigned on or before the deadline specified for bid submission. Failure to submit the original bid security within the prescribed time shall render the bidder **non-responsive** and may also result in **debarment of the bidder** in accordance with the KPPRA Rules.
5. **Bidders are advised** to carefully read and fully understand the BSDs, which provide complete instructions, eligibility criteria, terms and conditions, and detailed specifications of the items. Any request for clarification, if required, may be made in writing or through the E-PADS system, within stipulated time, or by contacting the office of the undersigned during official working hours.
6. **BISE Peshawar reserves the right** to accept or reject any or all bids, or to annul the procurement process, in accordance with the provisions of the KPPRA Rules.
7. **Bids shall be opened** electronically through the E-PADS system on the date and time specified in the BSDs, in the presence of bidders or their authorized representatives who choose to attend, in the committee room of BISE Peshawar.
