1. Board of Intermediate & Secondary Education Peshawar invites *individuals, Firms, Companies and General Order Suppliers*, to participate in the *National Competitive Bidding* to be conducted via **Single Stage-One Envelope procedure**, for the **sale of the assets (Sealed bid auction)**, described in para 3 below.
2. A bidder shall meet the qualification and eligibility conditions, as specified in the Qualification and Evaluation Criteria (Part II Section-III) of the *Bid Solicitation Documents*.
3. The assets for disposal are comprising the items, constituted into three lots, as briefly described below:

A	Used Answer Books 70 gsm	Rs 500,000
B	Used E-Marking Answer Books & OMR Bubble Sheets (80 gram paper)	Rs 300,000
C	Used Lose Paper/Envelopes etc	Rs 50,000

4. The assets for disposal are offered on "as is where is" basis, with no warranty whatsoever.
5. Prospective bidders may visit and inspect the assets proposed for disposal, located at BISE Peshawar, in liaison with the **Admin Officer, BISE Peshawar (Contact No. 091-9222038)**, during office hours, from the **date of publication of this invitation up to one day prior to the last date for submission of bids**.
6. The prospective bidders may inspect the Bid Solicitation Documents in the office of **Admin Officer, BISE Peshawar (Contact No. 091-9222038)**, during office time **up to one day prior to the last date for submission of bids**.
7. The prospective bidders may purchase a complete set of Bid Solicitation Documents (BSD) on submission of a written application along with a bank draft for payment of a non-refundable fee of Pak. Rupees **Rs.4000** in favour of Secretary, BISE Peshawar. As an alternative, the written application and the bank draft may be sent to the designated person by a registered post or courier service. On receipt of the application and the fee, the BSD will be sent to the applicant by a registered post or courier service. However, BISE Peshawar shall take no responsibility for or liability for the loss or late delivery.
8. A bidder shall furnish with his bid a Bid Security/Guarantee, as per table given at S.No 3, in any shape of written guarantee from a scheduled bank, excluding microfinance and other financial institutions, in the prescribed manner.
9. A bidder shall submit a sealed bid complete in all respects, accompanied by requisite supporting documents and Bid Security/Guarantee in the prescribed manner, in person or through an authorized representative to the office of **Secretary, BISE Peshawar on or before 23rd April 2026, at 12:00 PM**. A bid may also be submitted through a registered post or courier service, but that must reach the designated office before the deadline set for submission of the bids. A bid received later than the deadline shall be rejected and returned unopened.

10. The bids will be opened at Committee Room of BISE Peshawar on 23rd April 2026, at 2:00 PM in the presence of the bidders and/or their authorized representatives, who choose to attend the scheduled event.
11. The bids received and opened will be evaluated, following the criteria and methodology given in the Bid Solicitation Documents, and the results announced in the prescribed manner.
12. The Successful Bidder shall deposit a Performance Guarantee, in the specified amount and form, as mentioned in the Bid Solicitation Documents (Bid Data Sheet).
13. All taxes, duties, cesses, commissions, fees, etc., chargeable on the assets for disposal or the disposal proceedings; and all costs and expenses incurred on preparation and submission of the bids shall be paid by, and be liability of the bidders.
14. All terms and conditions set in the Bid Solicitation Documents shall apply to the bidding.
15. BISE Peshawar reserves the right to reject any or all bids following the provisions of Rule 47 of the Khyber Pakhtunkhwa Procurement of Goods, Works and Services Rules, 2014.
