B. Ranking and marking Criteria

Ranking and marking for eligible bidders will be based on the criteria given in succeeding paras regarding the *applicant's* Experience Record, Personnel Capabilities, Equipment Capabilities and Financial Soundness. The *Employer* reserves the right to waive minor deviations, if these do not materially affect the capability of an applicant to perform the contract. Sub-contractor's experience and resources shall not be taken into account in determining the Applicant's compliance with the qualifying criteria.
